

# HENDERSON LABRADORS

## HEALTH GUARANTEE

Henderson Labradors guarantees to the Original Purchaser this puppy to the best of our knowledge, to be in good health, free of diseases & has received 2 sets of vaccines and deworming (2,4,6, etc.) at the time of sale. Henderson Labradors guarantees the puppy to be free of genetic disease within the first year of its life. If a genetic disease is discovered by a veterinarian within the first year of the puppy's life, the purchaser may receive a replacement puppy (when available). The purchaser will be responsible for the transportation cost of shipping the dog back to the kennel and transportation of the new puppy to you. Transfer takes place the day that the puppy leaves Henderson Labradors. Henderson Labradors is not responsible for any vet bills acquired by the owner. If your puppy is diagnosed with a life-threatening illness (will die) within the first year of life, you would need to send a copy of all medical records showing that you have kept all shots and medical treatment current, there will need to be a statement from a veterinarian. If the dog dies within this one-year time frame, you must pay to have it autopsied to ascertain the reason of death. We will offer a replacement with a written statement from your vet that the pup had been spayed/ neutered. If there are any signs of abuse or neglect, over feeding or the pup has been bred (under 2 yrs. of age) this will void the health guarantee. If you decline a replacement puppy, then Henderson Labradors shall be under no further obligation and it will be deemed that you, the buyer, has released Henderson Labradors from any and all further claims and voids this health guarantee. You may also choose to keep your pet and not hold Henderson Labradors responsible for future illnesses that may occur. Although we are careful to breed animals with great temperaments, no guarantee can be given regarding your puppy's temperament, final weight or height. Henderson Labradors is not responsible for any vet bills acquired by the owner.

Henderson Labradors is not responsible for refunds due to human allergies, disability, not bonding with the puppy or because the temperament is not what you expected, but we will take a puppy back. (Henderson Labradors must get 1<sup>st</sup> option to get puppy back). The owner assumes all financial responsibility for the puppy including but not limited to vet expenses, AKC registration, etc. The owners assume responsibility to continue quality healthcare for the puppy. This puppy will require monthly worming and a series of vaccinations (9wk,12wk,16wk & rabies). Henderson Labradors highly encourages you to keep your puppy current with all necessary vet checks. You have 48 hrs. to take the puppy to a licensed veterinarian for a complete physical. If you fail this step then the health warranty is void.

## GENETIC GUARANTEE

Henderson Labradors genetically test all of our dogs through Orivet to insure we do not breed for any puppies to be affected/at risk by any of the common genetic problems in Labrador Retrievers. If your puppy comes back as affected/at risk for any of the genetic diseases Orivet tests for you can qualify for a replacement puppy when one becomes available. We are not responsible for any puppies that are "carriers" of any genetic diseases Orivet tests for. Being a "carrier" does not put your puppy at a poor health risk. To qualify for a replacement puppy all terms and conditions must be met in our general terms and conditions. All tests and vet records must be presented to Henderson Labradors. Henderson Labradors is not responsible for any vet bills or testing. Congenital Defects are not considered a genetic disease. As with any living being, defects can happen regardless of pedigree, history, parental health, and genetic testing.

## NO GUARANTEE IS GIVEN ON THE FOLLOWING

Parvo or Coronavirus, as immunities vary with each dog, female dogs being able to produce litters, redundant vulva or male dogs having both testicles, testacies that have not dropped, show potential, size of the dog, slipped-joints, or death due to negligence on the part of the buyer. eyes, elbows, patellar luxation, hip dysplasia, thickness of coat, skin allergies, puppy dermatitis, any and all mites, mange. The presence of parasites such as worms, guardia, coccidia, mites, lice, ticks, fleas do not make a puppy defective and are not included. Teeth, over or underbite or luxating patellas, hypoglycemia (low blood sugars) is not covered & hernias.

## **PAYMENTS AND DEPOSITS**

Full payment must be PAID at the age of 5 weeks of age unless arrangements have been made by Henderson Labradors. Failure to do so may result in the forfeit of the pup. All deposits shall be paid in the form of cash, money order, bank certified check, PayPal, Credit/Debit Card or personal check, as long as the personal check has time to clear the bank. (14 Days). A fee of \$45 will be charged for return checks. The remaining balance of the contract shall be paid prior to the shipping of the puppy or the puppy will not be shipped. Final balances must be paid by cash unless arrangements have been made by Henderson Labradors. No Personal Checks will be accepted for final payment. It's understood by the buyer that the Deposits & Final Payments are Non-Refundable under any circumstances and the buyer will not do a chargeback with their bank or credit/debit card company, PayPal, etc. There are no cash refunds.

## **PLEASE READ**

When the Temperature is hot, sometimes the female does not take and you can choose from another litter or wait till that female comes back into heat and be first in line. There are sometimes that a female will not take and we just don't know why. There may be times when a female has complications during pregnancy and the pups might not survive and you will be moved to a litter of your choice. If for some reason the buyer is unsatisfied or I cannot provide a puppy from said litter, the deposit will be placed on another litter. (Upon availability). Buyer is responsible for paying the difference in price. You may place your deposit on upcoming litters if not happy with current litter. If you put a deposit down and the choice of female and male don't produce what you want (sex or color) you can choose from another male and female and your deposit will go toward it or toward the same female for future litters. We try our best to know what they will have from previous litters (color wise) but this is out of our control as it is controlled by the dog's genes. If you are unable to keep your puppy for any reason, we will take the puppy back. This applies to the original purchaser only and we must be notified if ownership of the puppy changes.

When the pups are 3 weeks on age and you decided that don't want the pup that you first picked out and want a pup from a different litter and you have not told HENDERSON LABRADORS about the change, you will forfeit the 200.00 deposit and have to put another 200.00 deposit down to get pup of your choice and you will also give up all payments made on previous pup. You can transfer your deposit from litter to litter and we encourage that if the exact puppy is not available in a litter. Health Guarantee is VOID if the dog /puppy is sold to another party or given away.

Slander in any form against Henderson Labradors or Jessie Henderson is prohibited and will be a direct violation of this contract. Any purchaser found to slander Henderson Labradors or Jessie Henderson will be required to pay Henderson Labradors a \$3000 fee. Slander will be any written or verbal words that could potentially cause a loss of business to Henderson Labradors directly or indirectly. Any and all rude messages in any form will be considered a direct violation of this contract. The purchaser agrees that by signing this sales agreement that any rude or threatening messages WILL result in termination of contact between Henderson Labradors and the purchaser. The termination of contract will also result in Henderson Labradors being released of all obligations set forth in the contract.

Your puppy has been purchased as "Pet Quality" on Limited registration. You agree that your puppy will be spayed/neutered. You have 1 year to have pup spayed/neutered from time of birth and will have the veterinarian mail a copy of the spay/neuter procedure to Henderson Labradors. Failure to do this will result in health contract to become VOID and you will have to forfeit the pup over said pup to Henderson Labradors. Henderson Labradors will hold AKC papers until proof of spay is received. If you bred the dog or don't have he/she spayed/neutered, you will have to pay a fine of \$2500.00 and will be taken to court for breach of Contract.
